- Chief Blume updated that MFD completed content for (internal) strategic plan and forecast the direction of MFD for the next 2 years, five year, and ten year plan. CFP updated annually and requires constant updates from MFD for budget allocations, staffing, and equipment needs.

- Chief Blume was notified by FEMA that MFD was selected to received an \$8.1M SAFER Grant for three-year staffing support of entry level fire fighters. If accepted it would be the largest staffing grant ever in the state of Idaho. Also if accepted, the plan would be to move MFD Engine Companies to a four (4) person staffing model which is an NFAP-17 standard for fire operations. This would be a huge improvement in support and service delivery of the MRFPD. MFD and the city/city council has to either accept or reject the grant by 10/1/23.
